Guidance Notes – Deposit of Plans

- Two copies of this form should be completed and submitted with plans and particulars in accordance with the provisions of Regulation 12 of the Building Regulations 2014 (as amended).
- Subject to certain exemptions the Deposit of Plans attracts a fee payable by the person by whom or on whose behalf the work is to be carried out. The fee must accompany the deposit of plans. The fee is dependent upon the type of work proposed and is set out in the Guidance Notes – Fees sheet enclosed
- Section 11 of the Building Control Act 1991 provides for the passing and rejection of plans. It also specifies the time periods in which Deposited Plans are to be passed or rejected.
- This form shall be accompanied by the following - Plans to a scale of not less than 1:250 showing:
 - The size and position of the building, or the building as extended, and its relationship to adjoining boundaries;
 - The boundaries of the curtilage of the building or the building as extended, and the size, position and use of every other building or proposed building within that curtilage;
 - The width and position of any street on or within the boundaries of the curtilage of the building or the building as extended;
 - Particulars of the provision to be made for the drainage of the building or extension;
 - Particulars, if Section 12 of the Act applies, building over sewers etc of the precautions to be taken in building over a sewer;
 - Any other plans which are necessary to show that the work would comply with the Regulations.
- Section 17 of the Act makes it an offence for work or any part of that work to be carried out without plans having been passed by the building Authority.
- These notes are for general guidance only. Particulars regarding the deposit of plans are contained in Regulation 12 and in respect of fees the Building Regulations 2014 (as amended)
