The Department of Infrastructure makes the following Order under section 23 of the Road Traffic Regulation Act 1985.

1 Title

This Order is the Onchan (Various Roads) (Variation of Speed Limits) Order 2015.

2 Commencement

This Order comes into operation on 29 October 2015.

3 Variation of Speed Limit

The speed limit fixed by section 23 of the Road Traffic Regulation Act 1985 for driving a motor vehicle on roads within Onchan shall, in respect of the length of road specified in the first column be the speed specified in the second column of the Schedule.

4 Revocation

The Roads in Village Districts (Abolition and Variation of Speed Limits) Order 1974 shall be amended by revoking in the Second Schedule number 5 relating to the Village District of Onchan.
